#### TERMS AND CONDITIONS

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. ### Eligibility:

- 1. ## **How To Enter:**

- 8. To enter prize draw, buy a case of Crunchy Nut Nut Butter Bars for your store online or in stockists. Email a copy of your invoice/receipt showing a date of purchase during the Promotional Period, along with your full name, store name, store address and store telephone number, to enter@CNwin.co.uk
- 9. There are no restrictions to the amount of times one store and person can enter the promotion, subject to buying a new case of Crunchy Nut Nut Butter Bars and using a

#### Prize Details:
